

Young Life Australia Camp Registration Terms and Conditions

Consent to medical attention: I confirm my consent to the activities I/my child will engage in while on a Young Life Australia camp and understand these activities carry the normal risks associated with them. I acknowledge the staff and volunteer agents of Young Life Australia will take all possible care but cannot be held responsible for unforeseen accidents or illness arising. I hereby consent to all medical, hospital, rescue procedures being employed in the best interests of myself/my child and my next of kin/I shall be notified as soon as possible should the continuance of such procedures be necessary. All costs for medical services (other than basis first aid) are at the expense of you/your child.

Medical Information: Your/your child's medical information is securely stored online. It is kept confidential and only used in the best interest of you/your child's welfare.

Medication at camp: If you/your child requires prescription medication, they should bring enough medication for the duration of their stay. All medication should be in its original packaging and clearly labelled with your/your child's name, the dosage and frequency. You need to notify the camp organisers of all prescribed medications you/your child is taking if under 18.

Asthma and anaphylaxis: If you/your child suffer from asthma or anaphylaxis, they should have an asthma management plan or anaphylaxis action plan which has been prepared by your/their doctor. Download sample plan templates from [Australasian Society of Clinical Immunology and Allergy website](#) (link is external). If you/your child has a plan, please provide it to Young Life Australia staff prior to attending camp.

Participants with asthma need to bring their own peak flow meters and always carry their inhaler with them. Participants at risk of anaphylaxis need to bring at least one adrenaline auto injector. Young Life Australia does not provide them.

Discipline: Young Life Australia does not permit the use of alcohol or non-prescribed drugs. If in the event your/your child's behaviour is deemed by the organisers to be inappropriate or compromises the safety and or health of other participants on the camp, then Young Life Australia reserves the right to send you/your child home, at the earliest possible time, by the most effective mode of transport in conjunction with your co-operation. This will be at your/your child's expense.

Deposit: A non-refundable deposit of \$75.00 is required to register your place on Young Life Australia's camp program. Young Life Australia reserves the right to accept or reject any booking. Additional forms and approvals are required for any child under the care of the Community Services.

Payment Policy: Full camp payment is required no later than 21 days prior to camp start date. Failure to make full payment before camp commences may forfeit your/your child's place on camp.

Refund Policy: If you/your child withdraw from camp of your own accord, Young Life Australia's standard refund policy applies.

All camps must meet a minimum number to proceed. A full refund will apply if Young Life Australia cancels the camp. Camp details are subject to change without notice.

Disclaimer: In the unforeseen event of personal injury or illness sustained while on a Young Life Australia camp, or the loss of personal property except where such property was held in the custody of Young Life Australia staff or volunteer agents when lost while on a Young Life Australia camp, I hereby release, and exempt, and indemnify the organisers, sponsors, and all other persons involved in the organisation of the Young Life Australia camp, from all action, proceedings, demands, costs, expense, and claims whatsoever made or taken by any person arising out of my/my child's participation in such camp.

Mobile phones and other electronic devices: Young Life Australia may collect mobile phones and electronic devices on some camps. This will be made clear to campers and parents in the camp welcome information for each camp.

Social Media: Young Life Australia has official social media outlets which you can repost images on your personal account. Taking personal photos of campers or under 18's or posting photos with campers in them (even in the background) is strictly forbidden. Posting photos on personal social media accounts may breach Young Life Australia's child protection procedures and may be deemed by the organisers to be inappropriate or compromises the safety and or health of other participants on the camp and require disciplinary action.
