

Snapshot Summer Camp 2023

Abundance of Grace

The summer of 2023 signified a momentous return to our traditional locale in Jindabyne, following interruptions caused by bushfires and the COVID-19 pandemic. The event was particularly rewarding as we welcomed a new generation of committed staff and volunteers. Entering the camp environment often resembles stepping into an unpredictable sea, yet, our volunteers displayed outstanding love

and dedication, thereby impacting young lives. Remarkably, 73 campers - which accounts for an exceptional 90% of total attendees - chose to begin their journey of faith with Jesus. Such levels of engagement are rarely observed in camps primarily attended by unchurched youth in the Western context. We are deeply grateful for the God's grace and the community support that made these extraordinary outcomes possible.











Thriving safe spaces for high school and university students



Since its opening in November 2022, our Western Sydney drop-in centre has been flourishing, with a weekly attendance averaging between 70 and 100 young people. One such participant is Teah*, who has been a committed attendee since the onset of term 4. Her consistency saw her through the transformative experience of Young Life's Summer Camp, an opportunity made possible through the generous contributions of our supporters. Not only did Teah take part in the camp, but two of her siblings were able to join, much to the gratitude of their parents.

The Summer Camp played a pivotal role in Teah's faith journey. Throughout the week, we gained deeper insights into her family's story and witnessed her growing interest in spirituality. By the end of the camp, Teah was decided to make a bold step in her faith journey and has since joined a local church and attends our campaigners study group on a weekly basis.

This story is emblematic of the broader success we are experiencing at the drop-in centre.

Our community engagement is robust, with 15 active volunteers and a steady Bible study attendance of 5-7 young people per week. Many conversations are also emerging in the University space, where we are invited to help the local community strengthen their student engagement, student-led initiatives and the activation of their spaces. Young Life Blacktown is privileged, but this level of engagement and spiritual growth would not be feasible without the unwavering support from our financial partners, tying together the numerous facets of our successful outreach in Blacktown.

Expansion of safe spaces

The experience held unique significance for each participant. For some, it was their inaugural journey interstate, while for others, it was a first-time venture into abseiling or water sports.

The trip also provided a much-needed respite from the various pressures they face at home. Several of these young people have been involved with our organisation since their participation in Wyld Life. One such student, Stacey*, received a Bible from her Young Life leader upon her return, serving as an impetus for her faith journey.

Additionally, we initiated an after-school drop-in program on Mondays. The space offers complimentary hot chocolate, pancakes, games and activities. However, its most invaluable asset is the provision of

a welcoming environment and empathetic listeners.

Through this initiative, we have forged meaningful relationships, particularly with a group of young girls. One such individual used to discuss her social challenges at school quite frequently. It was heartening to observe a recent session where this issue was absent from our conversation.

Creating a safe and nurturing environment is imperative for this generation, as it serves as a source of hope and encouragement amidst the daily challenges they encounter in their teenage years.

At the conclusion of the camp season across the Balkans, we are thrilled by the numerous new beginnings unfolding among the youth.

We are exceedingly grateful for the opportunity to deliver the Gospel to almost 250 young people from Albania, Bulgaria, and North Macedonia—each in their language throughout the multiple summer camps.

This figure includes 27 Ukrainians residing in Bulgaria.

To our delight, some campers, including their family members, attended church services for the first time in Bulgaria and expressed an interest in acquiring a Bible, which goes to show the power of the seeds sown in the hearts of campers.

During the past year, we had the privilege of conducting three outreach camps and two Discipleship camps, attracting hundreds of teens from Belarus and Lithuania who were eager to hear the Gospel and deepen their faith. Impressively, 47 campers made the lifechanging decision to embrace faith for the first time. Additionally, we were honoured to welcome 45 Ukrainian teens to our Discovery Camp in Lithuania, specifically designed for discipleship.

One standout participant was 18-year-old Alex*, attending his final year as a youth camper. Known for his vibrancy and zest for life, Alex arrived at camp seeking new experiences like paintball, mountain biking, and rock climbing. However, the camp had more profound offerings in store for him. Amid the welcoming atmosphere, Alex engaged in meaningful conversations about Jesus, leading him to realise the existence of a spiritual life focused on hope and eternity.

In a note of gratitude, Alex conveyed his newfound understanding: "Here I learned and heard about God for the first time and more, and invited Jesus Christ to become my Lord and Saviour. I am glad that you gave me the opportunity to know Him..."

We are immensely grateful to our camp leaders, prayer teams, and financial partners for making transformative experiences like Alex's possible.
