



YOUNG LIFE AUSTRALIA CAMP REGISTRATION TERMS AND CONDITIONS: CAMPERS, SUMMER STAFF, WORK CREW, CABIN LEADERS, OTHER STAFF

Medical Information:

You/your child's medical information is securely stored. It is kept confidential and only used in the best interest of you/your child's welfare.

Consent to Medical Attention:

You confirm your consent to the activities you/your child will engage in while on a Young Life Australia camp and understand these activities carry the normal risks associated with them. You acknowledge the staff and volunteer agents of Young Life Australia will take all possible care but cannot be held responsible for unforeseen accidents or illness arising. You hereby consent to all medical, hospital, rescue procedures being employed in the best interests of you/your child and your next of kin/you shall be notified as soon as possible should the continuance of such procedures be necessary.

Medication at Camp:

If you/your child requires prescription medication, they should bring enough medication for the duration of their stay. All medication should be in its original packaging and clearly labelled with your/your child's name, the dosage and frequency. You need to notify the camp organisers of all prescribed medications you/your child is taking if under 18.

Asthma and Anaphylaxis:

If you/your child suffers from asthma or anaphylaxis, they should have an asthma management plan or anaphylaxis action plan which has been prepared by your/their doctor. Download sample plan templates from Australasian Society of Clinical Immunology and Allergy website (link is external). If you/your child has a plan, please provide it to Young Life Australia staff prior to attending camp.

Participants with asthma need to bring their own peak flow meters to camp and carry their inhaler with them at all times. Participants at risk of anaphylaxis need to bring at least one adrenaline auto injector as Young Life Australia does not provide them.

Disclaimer:

In the unforeseen event of personal injury or illness sustained while on a Young Life Australia camp, or the loss of personal property except where such property was held in the custody of Young Life Australia staff or volunteer agents when lost while on a Young Life Australia camp, you hereby release, and exempt, and indemnify the organisers, sponsors, and all other persons involved in the organisation of the Young Life Australia camp, from all action, proceedings, demands, costs, expense, and claims whatsoever made or taken by any person arising out of you/your child's participation in such camp.

Discipline:

If in the event you/your child's behaviour is deemed by the organisers to be inappropriate or compromises the safety and or health of other participants on the camp, then Young Life Australia reserves the right to send you/your child home, at the earliest possible time, by the most effective mode of transport in conjunction with your co-operation. This will be at your expense.

Drug & Alcohol (Including Vaping)

Young Life camps are drug and alcohol free events. In accordance with the law in NSW, Young Life does not permit young people under the age of 18 to be in possession or use non prescription drugs and alcohol, including vapes, while attending a Young Life camp. If these items are found they will be confiscated, and participants given warning. If Participants are engaging in this behavior for a second time, this will be deemed inappropriate behavior and dealt with in accordance with the "Discipline" conditions mentioned above.

Mobile Phones and Other Electronic Devices:

Young Life Australia collects mobile phones and electronic devices from campers when they arrive at the campsite. These will be stored securely for the duration of camp and returned to camper when they leave for the trip home.

We ask that the use of all phones and other devices by staff and volunteers be kept out of view of campers unless an emergency requires the use of your device.

Social Media:

Young Life Australia has official social media channels from which you can repost images on your personal account. Taking personal photos of campers or under 18's or posting photos with campers in them (even in the background) is strictly forbidden. Posting photos on personal social media accounts may breach Young Life's child protection procedures and may be deemed by the organisers to be inappropriate or compromises the safety and or health of other participants on the camp, trip or excursion and require disciplinary action.

Deposit:

A non-refundable deposit of \$110.00 may be requested to hold your place on Young Life Australia's camp program. This is at the discretion of the local Area Director.

Payment Policy:

Full camp payment is required by December 30. Failure to make payment arrangements before camp commences may forfeit you/your child's place on camp.

Refund Policy (Selection Criteria):

If you/your child do not meet the selection criteria* for participating in camp or positions are full, then a full refund of your deposit will be made as soon as possible. Preference is given to those meeting the selection criteria, meeting the necessary skills required to fill roles and availability to be at camp for the full week.

Refund Policy (Withdrawal):

If you/your child withdraws from camp of your own accord then Young Life Australia's standard refund policy applies:

Deposit	Non-refundable
30 days or more	Full refund (less deposit)
29-15 days	75% refund of fee (less deposit)
14-8 days	50% refund of fee (less deposit)
7 days or less	No refund

***Selection Criteria – Campers**

- Residing in or having a meaningful connection to a current local Young Life Area
- Age – being in school years 8-12 in the year of camp

***Selection Criteria – Volunteers**

- Personal connection with a current Young Life staff member or Volunteer Team Leader on camp team in the current year
- Willingness to abide by Young Life ministry principles and Code of Conduct
- Completing Young Life's Child Safety screening process
- Agreement with Young Life's Statement of Faith OR willingness to respect the Statement of Faith in the case of a position being filled by an external person for the purpose of fulfilling a set job description on camp e.g. Outdoor Adventure Guides
